**FTA'S OR FAILURE TO APPEARS:** OCCUR WHEN YOU FAIL TO SHOW UP FOR COURT OR TO THE COURT WINDOW TO PAY YOUR FINES DUE ON THE DATE OF THE SUMMONS GIVEN.
